



2018 Sponsorship Application Instructions & Form

PURPOSE and CRITERIA:

The intent of the **IBEW Local Union 77 Sponsorship Program** is to help promote our members and their families in community activities and to increase exposure and recognition for Local 77. This fund is not intended to be used to sponsor members in charity fundraisers or as a charitable contribution. Sponsorship is a two-way transaction rather than a donation; our support for an organization is given in return for the benefit of promoting the IBEW name, image, and services within our local communities. All sponsor benefits should be commensurate with the level of sponsorship.

IBEW Local 77's **printed** logo and/or wording must be **publically displayed**. All signage, as part of a sponsorship agreement, must conform to acceptable standards by the IBEW Local 77 Communications Committee.

IBEW Local 77 can also provide a union-made banner or sign to those units who have been approved. If a banner or sign is requested, the cost will be deducted from the amount requested.

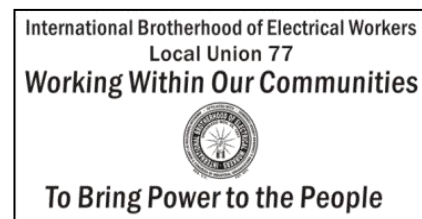
